THIS AGREEMENT made and entered into this <u>19</u> day of <u>DECEMBER</u>, 2006 by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the Fernandina Senior Squadron, Civil Air Patrol, hereinafter referred to as SQUADRON.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that there be a Fernandina Beach Senior Squadron, Civil Air Patrol, and

WHEREAS, the SQUADRON maintains a service to Nassau County and Fernandina Beach;

NOW, THEREFORE, the parties hereto agree as follows:

1. For and in consideration of the sum of \$1,500.00, which shall be paid in quarterly installments, during the months of November, February, May and August of the fiscal year, the SQUADRON does hereby agree to perform services that will benefit the residents of Nassau County. Said services to include but not be limited to the following:

- a. Provide help to anyone who may be in trouble on the water.
- 2. The SQUADRON shall make their financial records available to the Clerk of the Courts on behalf of the COUNTY for purposes of an audit, if requested by the COUNTY or the Clerk. The COUNTY shall require an audit of previous fiscal year's financial records performed by an independent accounting firm. Said audit report must be presented to the COUNTY and accepted by the Clerk of Courts before the May distribution will be made.
- 3. All facilities, programs and services should be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, and services that are compliant with both the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA) shall be considered a breach of the contract.
