This Work will provide the County and S2Li with the ability to respond to small on call assignments whose performance needs are immediate, such as responding to a regulatory inquiry or report deadline. This Work Authorization is intended to allow for S2Li to continue the provision of such services when the need arises.

Scope of Services

Task 1 - Miscellaneous On-Call Services

S2Li is to provide miscellaneous services to address assignments including but not necessarily limited to updating of existing reports, preparation of new reports, addressing rule changes, and other solid waste related assignments on an as-needed basis at the County's request. The total work effort is limited to the budget limit provided in this work authorization. S2Li shall provide the County with an estimate of the anticipated engineering fees and schedule associated with each on-call assignment. S2Li shall not proceed with any services prior to the receipt of authorization from the County.

Schedule
