

**AMENDED  
NASSAU COUNTY FIRE/RESCUE  
ANNUAL CONTRACT FOR PHARMACEUTICAL SUPPLIES 2006/2008**

**THIS AMENDED AGREEMENT** entered into this 10th day of January, 2007, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, hereinafter referred to as the "COUNTY", and the ACO Med Supply, hereinafter referred to as "VENDOR".

WHEREAS, the Board of County Commissioners of Nassau County awarded the bid, for the Nassau County Fire/Rescue - Annual Bid for Pharmaceutical Supplies 2006/2008, Bid No. NC06-036, to ACO Med Supply on the 8<sup>th</sup> day of November 2006, subject to execution of a contract; and

WHEREAS, the County entered into an agreement with ACO Med Supply, on the 27<sup>th</sup> day of November 2006, through September 30, 2008, with optional one-year extensions.



1. The Bid Price Sheet, attached hereto as Exhibit "A", is hereby amended to reflect additions or deletions.


2. The remaining provisions of the Contract shall remain in full force and effect.




