

**AMENDED
NASSAU COUNTY FIRE/RESCUE
ANNUAL CONTRACT FOR PHARMACEUTICAL SUPPLIES 2006/2008**

THIS AMENDED AGREEMENT entered into this 10th day of January, 2007, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, hereinafter referred to as the "COUNTY", and the Henry Schein/Matrx Medical, Inc., hereinafter referred to as "VENDOR".

WHEREAS, the Board of County Commissioners of Nassau County awarded the bid, for the Nassau County Fire/Rescue - Annual Bid for Pharmaceutical Supplies 2006/2008, Bid No. NC06-036, to Henry Schein/Matrx Medical, Inc. on the 8th day of November 2006, subject to execution of a contract; and

WHEREAS, the County entered into an agreement with Henry Schein/Matrx Medical, Inc., on the 27th day of November 2006, through September 30, 2008, with optional one-year extensions.



IN WITNESS WHEREOF, the parties have executed this Amendment to the Contract, the date and year first above written.


