AGREEMENT

RECEIVED

THIS AGREEMENT made and entered into ~~this~~ 2007 NOV 27 PM 3:26 of January, 2008, ~~2007~~, by and between the County of Nassau, a political subdivision of the State of ~~Florida~~ FLORIDA, hereinafter referred to as COUNTY, and the Special Olympics, hereinafter referred to as SPECIAL OLYMPICS.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that the SPECIAL OLYMPICS continue, and provide year-round sports training and athletic competition in a variety of Olympic-type sports for citizens with intellectual disabilities, and

NOW, THEREFORE, the parties hereto agree as follows:

1. For and in consideration of the sum of \$5,000.00, which shall be paid in quarterly installments, during the months of November, February, May and August of the fiscal year, the SPECIAL OLYMPICS does hereby agree to perform services that will benefit the residents of Nassau County. Appropriations necessary for the funding of this Agreement beyond 2008 shall be subject to the budget and appropriation by the Board of County Commissioners during the regular budget process. Said services to include but not be limited to the following:

- a. provide year round sports training and athletic competition in a variety of Olympic-type sports for individuals with intellectual disabilities by giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and participate in a sharing of gifts, skills, and friendship with their families, other Special Olympic athletes, and the communities of Nassau County.

2. The SPECIAL OLYMPICS shall make their financial records available to the Clerk of the Courts on behalf of the COUNTY for purposes of an audit, if requested by the COUNTY or the Clerk. The COUNTY shall require an audit of previous fiscal year's financial records to be performed by an independent accounting firm. The audit report must be received by the COUNTY and accepted by the Clerk of Courts before the May distribution will be made.


