AGREEMENT

THIS AGREEMENT made and entered into this <u>12th</u> day of <u>2008</u> 2007, by and between the County of Nassau, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and the Spay Nassau Program, hereinafter referred to as SPAY NASSAU.

WITNESSETH

WHEREAS, it is in the best interest of the citizens of Nassau County that there be a Spay Nassau Program; and

WHEREAS, SPAY NASSAU provides sterilization services to the pets of low-income pet owners in Nassau County.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. For and in consideration of the sum of \$5,000.00, which shall be paid in quarterly installments, during the month of November, February, May and August, SPAY NASSAU does hereby agree to perform services that will benefit the residents of Nassau County. Appropriations necessary for the funding of this Agreement beyond 2008 shall be subject to the budget and appropriation by the Board of County Commissioners during the regular budget process. Said services to include but not be limited to the following:
 - a. Continuing the present level of sterilization services provided to the pets of low-income residents in Nassau County.
- 2. SPAY NASSAU shall make their financial records available to the Clerk of the Courts on behalf of the COUNTY for purposes of an audit, if requested by the COUNTY or the Clerk. The COUNTY shall require an audit of previous fiscal year's financial records to be performed by an independent accounting firm. The audit report must be presented to the COUNTY and accepted by the Clerk of Courts before the May distribution will be made.
- 3. All facilities, programs and services shall be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, and services that are compliant with both the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA) shall be considered a breach of the contract.
