AGREEMENT

CR 115 - Old Dixie Highway Reconstruction Project (US-1 to Bypass Road)

AGREEMENT entered into THIS this dav 18th of , 2008, by and between the **BOARD** OF COUNTY <u>Jun</u>e COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "Owner", and A. J. Johns, Inc., 3225 Anniston Road, Jacksonville, Florida 32246, doing business as а corporation, hereinafter referred to as "Contractor".

WITNESSETH: For and in consideration of the payments and agreements hereinafter mentioned, the parties agree as follows:

1. Contractor shall perform all work and furnish all necessary labor, equipment, material, and transportation for CR-115 OLD DIXIE HIGHWAY RECONSTRUCTION (US-1 TO BYPASS ROAD), NASSAU COUNTY, FLORIDA, BID NO. NC08-001, hereinafter referred to as the "Work".

2. WORK includes, but is not limited to, clearing grubbing, fill, excavation, pavement, and pond construction, drainage structures, signing and pavement marking, erosion control, and maintenance of traffic. WORK be performed in accordance with the Florida is to Department of Transportation Standard Specifications for Road and Bridge Construction, dated 2007, The Florida Department of Transportation, Design Standards, dated 2006, and Nassau County Roadway and Drainage Standards Ordinance 99-17, dated May 1999.

3. The Contractor will commence the Work required by the Contract Documents within fifteen (15) calendar days after the date of the Notice to Proceed and will **SUBSTANTIALLY** COMPLETE the project within two hundred and fifty (250) consecutive calendar days, and fully complete the Project in a total of three hundred sixty-five (365) days after the date of the Notice to Proceed unless the period for completion is extended otherwise by the Contract Documents.

Time is of the essence in the construction of this Project. The Owner will suffer financial damage if this Project is not substantially completed on the date set forth in the Contract Documents. Therefore, the Owner and the Contractor specifically agree that the Contractor shall pay to the Owner the sum of Three Hundred and no/100 Dollars (\$300.00) per calendar day or any part thereof elapsing between the date established as provided in Section 16 of the General Conditions, and the actual date upon which substantial completion is achieved. Moreover, if after one hundred fifteen (115) calendar days after the date of substantial completion of the Project is achieved, the Project is not fully and finally complete, then the sum of Three Hundred and no/100 Dollars (\$300.00) per calendar day of any part thereof elapsing between the established date of final completion and the actual date of final completion shall be paid to the Owner by the Contractor.

These amounts to be paid to the Owner by the Contractor shall, in no event, be considered as a penalty or otherwise than the consequential and adjusted damages of the Owner because of the delay. Furthermore, the sums per calendar day or any part thereof set forth hereinabove, may be at the sole option of the Owner and may be deducted and retained out of the sums payable to the Contractor. If not so deducted, the Contractor shall remain liable therefore.

The contractor agrees to complete all work required to limit the period, where traffic is limited to one-way operation within the vicinity of Callahan Middle School, to one hundred and twenty (120) days.

2. The Owner has determined and declared the abovenamed Contractor to be the lowest responsible bidder on the above referenced Project, and has duly awarded this Contract to said Contractor, for the lump-sum named in the proposal, to-wit:

Two million four hundred seventy three thousand seven hundred twenty two and 00/100 (\$2,473,722.00) (Amount of Bid)

The Owner shall pay the Contractor for the Work performed as follows: Lump Sum amount for each of the items listed in the bid summary.

The Owner reserves the right to make additions or deletions to work and/or any portions of the work.

Compensation will be agreed to with a negotiated change order.

3. The Owner will pay the Contractor in a manner and at such times as set forth in the General Conditions such amounts as required by the Contract Documents.

4. The term "Contract Documents" means and includes the following:

7. This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.

8. All facilities, programs, and services should be compliant with the Florida Accessibility Code and the Federal Americans with Disabilities Act (ADA).

9. Appropriations necessary for the funding of this Agreement shall be adopted annually by the Board of County Commissioners during the regular budget process. Nonappropriation by the Board of County Commissioners will cause this Agreement to terminate.
