AMENDMENT NO. 3 / THIRD EXTENSION TO THE AGREEMENT FOR OUTSIDE NEGOTIATOR SERVICES

This will encompass the third of four available renewal years.
- 2. All other provisions of said Agreement and subsequent renewals not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
