- 1. In accordance with Section 20 of the Agreement dated November 27, 2006, the performance period is hereby extended for an additional one (1) year beginning October 1, 2009 and ending September 30, 2010.
- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
