AMENDMENT NO. 1/ FIRST EXTENSION TO THE
AGREEMENT FOR PHARMACEUTICAL SUPPLIES
FOR FIRE AND RESCUE

THIS ADDENDUM entered into this 10th day of September, 2008 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **BOUND TREE MEDICAL, LLC**, 5200 Rings Road, Suite A, Dublin, OH 43017-3557, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated November 27, 2006; and

WHEREAS, the original agreement provided for an initial term beginning November 27, 2006 and ending September 30, 2008, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, pursuant to Section 23, consideration of price increases at each renewal will be given provided such escalations are reasonable and acceptable to the County; and


WHEREAS, the parties desire to amend and extend said Agreement.

3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
4. Time is of the essence.




