In a conference call held on August 12th with Golder Assoc, Omar Smith, Ted Selby, Cathy Lewis, Edward Sealover, Lee Pickett & Becky Diden, it was discussed that an additional 12 inches (estimated 55,000 CY) of clean cover dirt would need to be placed over the top of the entire landfill as part of the FDEP closure permit requirements. Deadline to have the material in place is seven (7) days past the final waste placement. Due to ~~the~~ time constrictions the normal bid procedures cannot be followed. Solid Waste solicited a request for quotation from twelve (12) vendors to receive the best rate for the County. Anticipated delivery date is ASAP.

NOTE: 55,000 CY / 30 days = 1833 CY per day/ 18 CY dump trk = 101 loads per day over a 30 day period.





Background:

On August 12th a conference call was held with Wendy Karably of Golder Associates, Omar Smith of S2Li, Ted Selby, Cathy Lewis, Edward Sealoover, Lee Pickett & Becky Diden. In that meeting it was discussed that an additional twelve (12) inches (estimated at 55,000 CY) of clean cover dirt would need to be placed over the top of the entire landfill as part of the FDEP Closure Permit requirements. The deadline to have the material in place is seven (7) days past the final waste placement date which is September 30th. Due to the time constrictions at hand the normal bid procedures cannot be followed. Solid Waste solicited a request from twelve (12) vendors in our surrounding area to receive the best rate for the County. The anticipated delivery date of material is ASAP.

55,000CY / 30days = 1833 CY per day / 18CY dump trk = 101 loads per day over a 30 day period.

D&D Site Work was the lowest bid at \$5.00 per CY delivered (see attached tabulation sheet).


