

A mandatory pre-bid conference was held May 1, 2008 at the James S. Page Governmental Complex. Copies of the sign-in of those who attended the meeting are attached (see Attachment "A"). This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents.

Charlotte Young, Contract Manager opened the meeting with discussion on the bid submittal requirements. <u>Bids are due by June 3, 2008 at 2:00 p.m.</u> (error noted on the agenda 3. a. i) Caution was given to the bidders, if they plan on delivering their bid on the deadline date, to allow sufficient time for security clearance at the Judicial Annex which is located 76347 Veterans Way in Yulee, Florida. Bid received after 2:00 p.m. on June 3, 2008 will not be accepted.

Douglas Seaman, Director of Engineering Services discussed the topic outlined in the agenda provided (see Attachment "B"). Highlighted points are as follows:

#### Introductions

- This is a Board of County Commissioners of Nassau County project, not a Florida Department of Transportation project.
- > The project shall be constructed according to FDOT standards

We do not have them in our possession. If there will be an extra charge the County would not want to incur additional cost.

Q21. Are you going to furnish a copy of the sign-in sheet?

A21. Yes, a copy will be provided with the addendum.

**Q22.** The work in the US 1 (corrected from US 301) is FDOT right-of-way so there is no permit required for that or is it already incorporated into the plans?

A22. The improvements are just going to make it a tie in shown on the plans but when we tried to get a permit for the tie-in they issued the permit but the County has to do a left turn lane improvement permit also. That left hand turn lane will be a change order: we didn't have time to submit it with this set of plans. We'll get it designed, but again, it is my understanding that we have a DOT connection permit.
