## EASEMENT

THIS AGREEMENT dated this 16th day of January HIGGINBOTHAM 2008, by and between the NORWOOD Ε. hereinafter referred to as "Grantor" and BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, political subdivision of the State of Florida, hereinafter referred to as the "County".

FOR and IN CONSIDERATION of ten and no/100 Dollars (\$10.00), and other mutually agreed upon consideration, the parties agree as follows:

- 1. Grantor hereby grants to the County two easements for ingress and egress and power lines across the northern and eastern boundaries of the real property described in a Warranty Deed from the Grantor to Jeffery W. Windsor, dated July 18, 2003, and recorded in Nassau County Official Record Book 1170, Page 725-726.
- 2. Said easements were retained by Grantor in the conveyance referenced in the paragraph above for the purpose of providing access to property, a portion of which Grantor conveys to County by Warranty Deed of even date.
- 3. Both the County and the Grantor shall have right to said easements.

- 4. Said easements are appurtenant to the dominant and servient estates.
- 5. Said easements are necessary for access to the fifteen acres tract the Grantor conveys to the County.
