## AMENDMENT NO. 1 / FIRST EXTENSION TO THE AGREEMENT FOR FUELS, OILS & LUBES

WHEREAS, the parties desire to amend and extend said Agreement; and

WHEREAS, due to the increase in fuel prices, the Vendor requests an adjustment in the rate charged for Environmental Impact Fees from \$0.007 per dollar to \$0.015 per dollar, in

order to cover increase cost of transporting and delivery. The amount charged for this fee shall not exceed \$50.00 per invoice.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- In accordance with Section 20 of the Agreement for Fuels, Oils & Lubes dated November 8, 2006, the performance period is hereby extended for an additional one (1) year beginning October 1, 2008 and ending September 30, 2009.
- 2. The Environmental Impact Fee charge, referenced on the Bid Price Sheet, Section F, shall be \$0.015 per dollar amount of product purchased; in no event shall said fee exceed \$50.00 per invoice.
- 3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 4. Time is of the essence.
