**AMENDMENT NO. 5 / FIFTH EXTENSION TO THE
AGREEMENT FOR DISASTER RECOVERY SERVICES**

THIS ADDENDUM entered into this 13th day of August, 2008 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **ASHBRITT, INC.**, 480 South Andrews Avenue, Suite 103, Pompano Beach , FL, 33069, and **GRUBBS EMERGENCY SERVICES, L.L.C.**, 1115 S. Main Street, Brooksville, FL, 34601, and **TIM-PREP, INC.**, 18500 MacClenny Road, Jacksonville, FL, 32234, (hereinafter collectively referred to as the "Contractor").

WHEREAS, the parties entered into an Agreement dated August 12, 2004; and

WHEREAS, the original agreement provided for an initial term of four months beginning June 1, 2004, and ending September 30, 2004, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties entered into subsequent renewal periods for the period of October 1, 2004 through September 30, 2008; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 31 of the Agreement for Disaster Recovery Services dated August 12, 2004, the performance period is hereby extended for an additional one (1) year beginning October 1, 2008 and ending September 30, 2009.
2. Amended prices have been submitted and are attached hereto as Exhibit "A". These updated prices will replace Attachment 2 from the original agreement.
3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
4. Time is of the essence.




