**AMENDMENT NO. 1 / FIRST EXTENSION TO THE**  
**AGREEMENT FOR WEBSITE DEVELOPMENT SERVICES**  
**AND PROMOTION**

THIS ADDENDUM entered into this 22nd day of September, 2008 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **.COM MARKETING INTERACTIVE ADVERTISING AGENCY**, 400 n. Wymore Road, Winter Park, Florida 32789 (hereinafter referred to as "Contractor").

**WHEREAS**, the parties entered into an Agreement dated September 24, 2007 for the development and implementation of a program and promotional campaign to attract tourists to web domain promoting tourism in Nassau County; and

**WHEREAS**, the original agreement provided for an initial term of one (1) year beginning October 1, 2007 and ending September 30, 3008, with an option to extend for two (2) additional one-year extensions upon mutual contract between the Contractor and the County;

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 3.5 of the Agreement for Website Development Services and Promotion dated September 24, 2007, the performance period is hereby extended for an additional one (1) year beginning October 1, 2008 and ending September 30, 2009.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
