## AMENDMENT NO. 2 / FIRST EXTENSION TO THE AGREEMENT FOR COLD PLANT MIX

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 20 of the Agreement for Ready Mix Concrete dated October 22, 2007, the performance period is hereby extended for an additional one (1) year beginning October 1, 2009 and ending September 30, 2010.
- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
