AMENDMENT NO. 2/ SECOND EXTENSION TO THE
AGREEMENT for MONITORING SERVICES AT SEVERAL COUNTY

THIS ADDENDUM entered into this 30th day of November, 2009 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Atlantic Security Consultants**, 1714 Cesery Boulevard, Jacksonville, Florida 32211, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated January 9, 2008 for monitoring services for Yulee Sports Complex, County Maintenance Office, County Coordinator's Administrative Office, Judicial Complex, Historic Courthouse, Annex Building, and James S. Page Governmental Complex; and


