AMENDMENT NO. 2 / SECOND EXTENSION TO THE AGREEMENT FOR FUELS, OILS & LUBES

WHEREAS, the original agreement provided for an initial term beginning November 8, 2006 and ending September 30, 2008, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

whereas, the parties agreed to amend the original agreement on June 18, 2008 to extend the contract for the period commencing October 1, 2008 and ending September 30, 2009 and also allow for price increase for Environmental Impact Fees; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 20 of the Agreement for Fuels, Oils & Lubes dated November 8, 2006, the performance period is hereby extended for an additional one (1) year beginning October 1, 2009 and ending September 30, 2010.
- 2. In accordance with Section 23 of the Agreement for Fuels, Oils & Lubes dated November 8, 2006, the markup over OPIS rack average for fuel will increase by \$.05 per gallon from \$.123 to \$0.173.
- 3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 4. Time is of the essence.
