Victor,

Thank you for the scheduling information regarding the jack and bore. This proposed schedule comports with my notes from our project status meeting yesterday. However, at that meeting we notified you that your current contract time allotted ends on 11/27/09 and requested a final schedule to complete the project and a request for any time extensions due to AJ Johns related to the delay caused by the discovery of unforeseen utilities in the right of way and any CSX delays experienced due to the County. We have not received a schedule but have reviewed the requests for time extensions.

With regard to AJ Johns CO #22 – "Request for additional time due to conflict with existing City of Callahan 6" forcemain" we concur with your analysis and are in the process of adding 14 calendar, as requested.

With regard to AJ Johns CO #21 – "Request for additional time due to delays caused by CSX processing the railroad permit" we have reviewed your analysis and believe that AJ Johns is due 18 additional days due to Nassau County's time to issue payment and execute the "Encroachment Agreement" agreement with CSX. While it is evident that CSX's process could have gone more smoothly for this project the procurement of this permit was a contractual obligation of AJ Johns upon Nassau County's acceptance of your bid and as stated in the contract documents. This permit and its status has been discussed at every bi-weekly coordination meeting since AJ Johns mobilized and began construction. Our documented attempts to assist AJ Johns with the procurement of this permit do not relieve AJ Johns of this contractual obligation. We also note that we are on contract day 487 and the CSX permit has been a requirement since day one and was applied for on contract day 327. We will therefore award an additional 18 days for CSX delays.

Please submit a schedule to complete all activities on this project as soon as possible. Nassau County appreciates the working relationship we have had with AJ Johns during this project and will likely award additional time to the contract, however we will not award time that subsequently causes the County to incur any costs due to such extension.
