

**SECOND AMENDMENT TO PURCHASE, INSTALLATION AND MAINTENANCE SERVICE CONTRACT**

**Elite Premier Purchase, Installation and Maintenance Service**

**THIS AMENDMENT** made and entered into by and between the **Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Second Amendment to Purchase, Installation And Maintenance Service Contract for Elite Premier Purchase, Installation and Maintenance.

**WHEREAS**, the parties entered into the original contract on the 20<sup>th</sup> day of January, 2009; and

**WHEREAS**, the equipment installation has been installed and is operational, and the maintenance and warranty period has begun; and

**WHEREAS**, the contract allows for the Solacom and PlantCML Extended Warranty to be adjusted annually by the manufacturer and provided by AK Associates at cost with no additional markup; and

**WHEREAS**, the State of Florida E911 Board approved the grant request, E911 Rural County Grant 09-10-24 in the total amount of \$41,875.00 as follows: AK Elite Premier

Contract Tracking No. CM1400-A2  
Maintenance (Year 2) \$25,625.00, PlantCML Extended Warranty  
(Year 2) \$8,325.00 and the Solacom Extended Warranty (Year  
2) \$7,925.00.

**NOW, THEREFORE,** for and in consideration of the  
promises and mutual covenants and understanding contained  
herein, the receipt and sufficiency of which is hereby  
acknowledged, the parties agree to amend SECTION II, 2.

Warranty Payment Schedule as follows:

**PlantCML Extended Warranty**

- Year 2           \$8,325.00

**Solacom Extended Warranty**

- Year 2           \$7,925.00

All other provisions of the original contract shall  
remain the same and in full force and effect.
