

THIRD AMENDMENT TO PURCHASE, INSTALLATION AND MAINTENANCE SERVICE CONTRACT

Elite Premier Purchase, Installation and Maintenance Service

THIS AMENDMENT made and entered into by and between the **Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Third Amendment to Purchase, Installation And Maintenance Service Contract for Elite Premier Purchase, Installation and Maintenance.

WHEREAS, the parties entered into the original contract on the 20th day of January, 2009; and

WHEREAS, the equipment installation has been installed and is operational, and the maintenance and warranty period has begun; and

WHEREAS, County submitted to the E911 Board an Application for the E911 Rural County Grant Program on September 28, 2009 for the installation of a new mapping module which will effectively aid call takers in answering and responding to 911 calls that will work with the new PlantCML ECS-1000 and Solacom system; and

WHEREAS, the State of Florida E911 Board approved the partial grant request, E911 Rural County Grant 09-10-32 in the amount of \$77,005.00 for the purchase of the QuickPoint Dispatch Mapping System; and

WHEREAS, in accordance with the E911 Rural County Grant, the Nassau County Coordinator approved AK Associates as a sole source provider for the purchase, installation, and maintenance of the QuickPoint Dispatch Mapping System.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. Contractor shall perform on-site installation, configuration, and testing of the QuickPoint Dispatch Mapping System, and any necessary formatting for any minor on-site functional requirements. Installation will also include the oversight of the functioning of QuickPoint, both formal and informal training and first year support.

2. Compensation to Contractor for the QuickPoint Dispatch Mapping System shall be as follows:

3. All other provisions of the original contract as amended shall remain the same and in full force and effect.
