## ADDENDUM NUMBER 4 TO THE LEASE AGREEMENT FOR NASSAU COUNTY COUNCIL ON AGING, INC.

THIS ADDENDUM is entered into this <u>9th</u> day of <u>June</u> 2010, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision** of the State of Florida, (hereinafter referred to as the "County") and Nassau County Council on Aging, Inc., 1367 S. 18<sup>th</sup> Street, Fernandina Beach, Florida 32034, (hereinafter referred to as the "Council").

WHEREAS, the County entered into a Lease Agreement with the Council on August 21, 2006 for the lease of two vehicles: one Ford eighteen (18) passenger bus and one Ford nine (9) passenger van; and

WHEREAS, the term of said Agreement was for a period of one year starting on August 21, 2006 and ending on August 20, 2007; and

WHEREAS, paragraph three (3) of said agreement states that additional rental terms for one (1) year periods may be negotiated between the parties and shall be mutually agreed to in writing and executed with the same formalities as the original agreement; and

WHEREAS, the parties entered into subsequent renewals for the periods of August 21, 2007 to August 21, 2008, and August 22, 2008 to August 21, 2009; and August 22, 2009 to August 21, 2010; and

WHEREAS, the parties now desire to extend the term of the Lease Agreement for an additional one (1) year period.

**NOW THEREFORE**, in consideration of the covenants hereinafter contained, it is mutually agreed as follows:

- 1. The additional one year period rental term shall commence on August 22, 2010 and terminate on August 21, 2011.
- All other provisions of the Lease Agreement dated August
  21, 2006, not in conflict with this Addendum, shall
  remain in full force and effect.
- 3. Time is of the essence.
