INTERLOCAL AGREEMENT

AN AGREEMENT entered into this 14th day of April, ²⁰¹⁰~~2009~~, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the CITY OF FERNANDINA BEACH, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as the "City".

WHEREAS, it is the purpose and intent of this agreement for the City and the County, pursuant to Section 163.01, Florida Statutes, to cooperate and provide for a means by which each governmental entity may exercise its respective powers, privileges and authorities which they share in common and which each might exercise separately in order to further a common goal; and

WHEREAS, the County has determined that it is in the best interest of the citizens of Nassau County to remain as the subgrantee for the FEMA Hazard Mitigation Grant Contract #: 07HM-4@-04-55-01-080 in order to prevent these federal funds from being withdrawn; and

WHEREAS, the County has determined that it is in the best interest of the citizens of Nassau County to enter into this Interlocal Agreement to allow the City to perform the grant contract's scope of work by assuming responsibility for wind retrofitting the Fernandina Beach Fire Rescue Headquarters; and

WHEREAS, the cost of wind-retrofitting the Fire Rescue Headquarters has increased by \$23,793 since the County executed a grant contract with the Florida Division of Emergency Management (FDEM) in 2007, and the FDEM has approved a corresponding increase of the federal match, which is seventy five percent (75%) from \$37,560 to \$55,405.07 for the City's Fire Station project and extended the period of performance from January 26, 2010 to August 31, 2010; and

WHEREAS, the City has determined that it is in the best interest of the citizens of Fernandina Beach to enter into this Interlocal Agreement and has agreed to provide the requisite twenty-five percent (25%) match of \$18,468.00 for the project with the additional \$55,405.07 coming from federal funds pursuant to the FEMA Hazard Mitigation Grant Contract #07HM-4@-04-55-01-080.

NOW THEREFORE, the parties agree as follows:

1. The foregoing recitals are true and correct and are hereby fully incorporated into this Agreement by this reference.
2. The County agrees to continue in the role of subgrantee for the FEMA Hazard Mitigation Grant Contract #: 07HM-4@-04-55-01-080.
3. In accordance with Florida Department of Emergency Management rules, the City agrees to contribute the total cost of the project at \$73,873.07 to the County before any construction commences and the County agrees to contract with and pay \$73,873.07 to the vendor;
4. The City agrees to cooperate with the County to ensure that all FEMA rules and regulations are followed in procurement procedures and construction;
5. Upon completion of the project, the County agrees to draw down the federal share of funds in the amount of \$55,405.07 and issue a check immediately for that amount to reimburse the City once the County has received the grant reimbursement from the State.
6. Any notices required pursuant to this Agreement shall be to the following:


