

In response to New Business "M" item number 3 from the 6/9/10 progress meeting, and Field Order #1, below is a cost proposal to remove approximately 90-100 linear feet of existing white stripe on the southeast section of roadway stations 98+99.67 to 99+88.49 (Rt) for re-alignment. Two prices are provided below based on method of removal.

- 1. The first price provided is to remove approximately 90 lf of existing white stripe on the southeastern edgeline stations 98+99.67 to 99+88.49 (Rt) by method of mechanical grinding. The price to perform this work is \$165.00.
- 2. The second price provided is to remove approximately 90 If of existing white stripe on the southeastern edgeline stations 98+99.67 to 99+88.49 (Rt) by method of hydroblasting. The price to perform this work is \$1,650.00.

Please specify which method you prefer for removal and we will proceed. Because the County is only requiring the 6" yellow skip as temporary striping called out on sheet 34 item 8 after the first lift of asphalt, the removal of existing striping can be done during the final lift and relevant final striping operations so the taper can be made.
