AMENDMENT NO. 1 / FIRST EXTENSION TO THE
AGREEMENT FOR MANHOLE/WETWELL REHABILITATION FOR
NASSAU AMELIA UTILITIES

THIS ADDENDUM entered into this 14th day of October, 2009 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **CONCRETE CONSERVATION, INC.**, 9716 Mining Boulevard West, Suite 2, Jacksonville, Florida 32257, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated August 13, 2008, for the WW-4 Inflow/Infiltration Correction Program for Nassau Amelia Utilities; and


WHEREAS, the original agreement provided for an initial term beginning August 13, 2008 and ending August 12, 2009, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties desire to amend and extend said Agreement; and

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 2 of the Agreement for Manhole/Wetwell Rehabilitation dated August 13, 2008, the performance period is hereby extended for an additional one (1) year beginning August 13, 2009 and ending August 12, 2010.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.


