**AMENDMENT NUMBER 3/THIRD EXTENSION TO THE
GOLD MAINTENANCE AGREEMENT FOR NASSAU COUNTY JUDICIAL CENTER**

THIS ADDENDUM entered into this 11th day of July, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **THYSSENKRUPP ELEVATOR CORPORATION**, 6942 Philips Parkway Drive South, Jacksonville, Florida 32256, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated January 23, 2009; and

WHEREAS, the original agreement provided for an initial term beginning October 1, 2008 and ending September 30, 2009, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties agreed to extend the agreement for the period beginning October 1, 2009 and ending September 30, 2010, and for the period beginning October 1, 2010 and ending September 30, 2011; and


WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

Contract Number CM387-A3

1. In accordance with "Term" section of the Gold Maintenance Agreement for Nassau County Judicial Center dated January 23, 2009, the performance period is hereby extended for an additional one (1) year beginning October 1, 2011 and ending September 30, 2012.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
