## AMENDMENT #4/THIRD EXTENSION TO THE AGREEMENT FOR BEACH AND PARK CLEANING ANNUAL CONTRACT

WHEREAS, the parties desire to amend and extend said agreement.

**NOW THEREFORE**, in consideration of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

 In accordance with Section 17 of the Agreement dated January 28, 2008, the performance period is hereby extended for an additional one (1) year beginning October 1, 2011 and ending September 30, 2012.

- 2. All other provisions of the Agreement dated January 28, 2008, not in conflict with this Addendum, shall remain in full force and effect.
- 3. Time is of the essence.
