

**AMENDMENT NUMBER 3/ THIRD EXTENSION TO THE  
AGREEMENT FOR ASPHALT CONCRETE (S1, S111, & MILLING)**

THIS ADDENDUM entered into this 17th day of August, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **OLDCASTLE SOUTHERN GROUP, INC.**, a Georgia corporation formerly known as APAC - SOUTHEAST, INC., 11482 Columbia Park Drive W., Suite 3, Jacksonville, Florida 32258, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated October 22, 2007 to provide Asphalt Concrete (S1, S111 & Milling); and

**WHEREAS**, the original agreement provided for an initial term beginning October 22, 2007 and ending September 30, 2009, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

**WHEREAS**, the parties agreed to extend the agreement for the period beginning October 1, 2009 and ending September 30, 2010, and for the period beginning October 1, 2010 and ending September 30, 2011; and

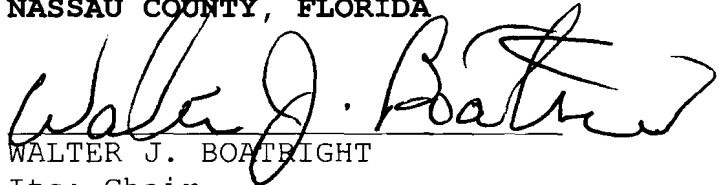
**WHEREAS**, effective December 31, 2010, APAC-Southeast, Inc. changed its legal name to Oldcastle Southern Group, Inc.; and

**WHEREAS**, the parties desire to amend and extend said Agreement entered into on October 22, 2007.

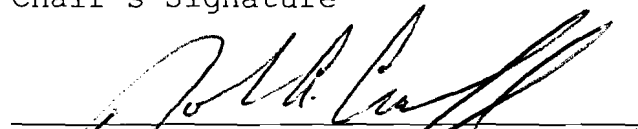
**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. Name Change. This amendment is an administrative change to the agreement which both parties acknowledge that, effective December 31, 2010, APAC-Southeast, Inc. changed its name to Oldcastle Southern Group, Inc., but will not change any other corporate formalities.
2. In accordance with Section 20 of the Agreement dated October 22, 2007, the performance period is hereby extended for an additional one (1) year beginning October 1, 2011 and ending September 30, 2012.
3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
4. Time is of the essence.

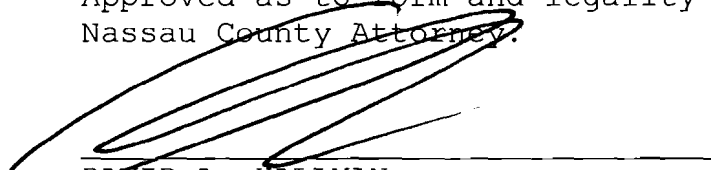
