**AMENDMENT NUMBER 2/SECOND EXTENSION TO THE
AGREEMENT FOR MONITORING SERVICES AT HILLIARD BRANCH
LIBRARY**

THIS ADDENDUM entered into this 7th day of October, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **B.J. BARR'S PERSONAL SAFETY DEVICES dba ISLAND SECURITY**, P.O. Box 16539, Jacksonville, Florida 32245, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated September 10, 2009 for monitoring services for Hilliard Branch Library; and

WHEREAS, the original agreement provided for an initial term beginning October 1, 2009 and ending September 30, 2010, and allowed for renewals of one year periods; and


WHEREAS, the parties agreed to extend the agreement for the period beginning October 1, 2010 and ending September 30, 2011; and

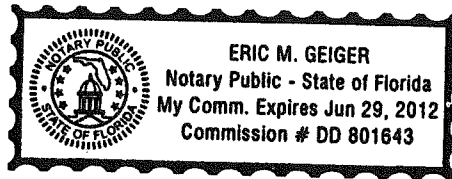

2. TERM OF THIS AGREEMENT

2.1 The primary term of this Agreement shall be for a period of 30 Days years from the date of first billing. Unless otherwise provided under the terms of the Renewal Option, this Agreement shall automatically renew for a period of one (1) year at the end of such primary term or any renewal term thereafter. Client shall give written notice to Company; thirty (30) days prior to cancelling.

Company shall have the right to assign this Agreement to any other person, firm, or corporation without notice to the Client and shall have the further right to subcontract any services it may be obligated to perform.

All equipment installed by Company for the transmission of electronic signals shall, at all time, remain the property of Company.

Should any part of this Agreement be deemed to be illegal, invalid, inoperative, all remaining parts shall remain in full force and effect.
