PROJECT NAS-OC-TS NASSAU COUNTY ON-CALL PUBLIC SAFETY COMMUNICATIONS TECHNICAL SUPPORT

1.0 Introduction

This task provides a framework for *FE* to respond to ad-hoc, short-term assignments regarding public safety mobile radio technology, microwave systems, CAD, MDTs, "911", dispatch center systems, and information technology systems. Through this statement of work, Nassau County is provided with the mechanism to direct *FE* consulting efforts in an orderly fashion while maintaining control and visibility throughout the task.

2.0 <u>Tasks to be Performed</u>

An assignment within this task will be initiated by written correspondence (email or letter) between *FE* and Nassau County.

1. Assignments within this task may consist of any of the following:

- FE may offer informal advice or conduct technical research.
- FE may assist in administrative issues such as FCC license renewals.
- FE may interface with Nassau County management and radio systems users.
- FE may generate RFP's and review proposals for communications systems.
- **FE** may conduct meetings with potential vendors and assist Nassau County in contract negotiations.
- FE may perform program planning and design reviews.
- *FE* may perform analyses of center operations and system/technology utilization and develop improvement recommendations.
- FE may conduct special presentations on select subjects.

- *FE* may provide support in areas such as operations, engineering, or administration for public safety mobile radio services.
- FE may provide radio coverage analysis as directed.
- FE may provide oversight of radio system vendor activities
- **FE** may provide training support
- 2. Milestones and deliverables within this task may consist of any of the following:
 - FE may conduct program review meetings or technical seminars.
 - **FE** may conduct oral presentations to Nassau County upon requested subjects.
 - FE may generate program plans using Microsoft Project and other software.
 - FE may generate brief memoranda, reports, or white papers on findings.
 - **FE** may participation at meetings to support findings or to discuss assignments.
 - *FE* may provide coverage analysis results in formats defined by Nassau County.

2.0 <u>Personnel</u>

FE will select consultants with the specialties, background, and experience best suited for each assignment. *FE* will designate Mr. Terry Forehand, Senior Consultant, as the primary contact to work with the County to allocate *FE* specialists and consultants as required. Administrative support will be assigned as necessary. Additional tasking will be performed in accordance with the rates in Schedule A.

3.0 <u>Schedule</u>

This task will begin upon execution of this statement of work and remain active for one year or until expiration of the purchase order and any amendments or extensions.

3.0 Estimated Costs

Tasks will be performed on a time and materials basis in accordance with the rates in Schedule A. Travel and other direct costs, if any, will be billed in accordance with Schedule A. This SOW initially authorizes a maximum of \$4,500 which includes labor, travel, and other direct costs.

Invoices will be submitted monthly. The invoices will detail each task assignment, the personnel assigned, the number of hours charged, and details regarding travel and other direct costs.

Federal Engineering will notify Nassau County should additional funding be required. Authorized funding may be increased by a written modification to this task

duly executed by both Nassau County and FE or a purchase order modification.

6.0 **Assumptions and Constraints**

FE professionals will be directed by Nassau County according to the tasks to be performed. The scheduling of FE resources will be mutually agreed upon based upon the needs of Nassau County and the availability of the specific FE consultants.

If any documentation is required for delivery, FE will deliver its documents electronically via email attachments and/or CDROM in MS Office. FE can also deliver documentation in hard copy format should Nassau County require.

The FE professionals' ability to fulfill tasks depends heavily upon the directions given by Nassau County. In addition, the FE professionals' ability to fulfill task depends on the willingness and ability of Nassau County, equipment vendors, service providers, third parties, and others to provide information in a timely manner, and upon the accuracy of the information as supplied. The accuracy of input data, whether provided in electronic or hard copy form, and the recommendations, actions, maintenance tasks, system designs, and procurements derived therefrom cannot, therefore, be warranted by *FE* nor can the performance, suitability, or reliability of said systems be warranted by FE.

Work under this SOW will commence upon execution by both parties and will continue until all funds are expended.
