The Contract is changed as follows: Contractor and Nassau County agree to amend the contract to pay for overrunning existing contract items to reconstruct the transition of Goffinsville Road to connect with CR-107. The connection of Goffinsville Road occurs at the low point of the inside superelevated curve of CR-107. The existing plans limited the transition to a short distance that resulted in a severe grade break. It was anticipated that the grade break would have been harsh for vehicles with trailers and it was agreed to lengthen the transition and adjust the grades per the EOR's plan revision details (attached).

The supplemental Grading Detail was developed using the FDOT Index 515 sheet 7 TURNOUTS. Algebraic difference "A" less than 14% does not required any transition. We have 11.4% (7.5% down + 3.9% up). In consideration to the RV and boat trailers traffic that access the park, we proposed 10' transition. The Greenbook vertical geometry design criteria is applicable to different speed conditions.


