**AMENDMENT NUMBER 2/SECOND EXTENSION TO THE AGREEMENT FOR  
THE AMELIA CONCOURSE MSBU LANDSCAPE MAINTENANCE ANNUAL  
CONTRACT**

THIS ADDENDUM entered into this 16th day of May,  
2012, by and between the **BOARD OF COUNTY COMMISSIONERS OF  
NASSAU COUNTY, FLORIDA**, a political subdivision of the  
**State of Florida**, hereinafter referred to as "County", and  
**Trim All Lawn Service, Inc.**, located at 97030 Elk Creek  
Court, Fernandina Beach, Florida 32034, hereinafter  
referred to as "Contractor".

**WHEREAS**, the parties entered into an agreement dated  
July 27, 2009; and

**WHEREAS**, the original agreement provided for an  
initial term beginning August 1, 2009 and ending July 31,  
2011, with an option to extend upon written agreement of  
both parties for three (3) additional one (1) year periods;  
and


**WHEREAS**, the parties agreed to extend the agreement  
for the period beginning August 1, 2011 and ending July 31,  
2012; and

**WHEREAS**, the parties desire to amend and extend said  
Agreement.

**NOW, THEREFORE**, in consideration of the mutual  
covenants and agreements hereinafter contained, the parties  
hereto agree as follows:

1. In accordance with Section 2 of the Agreement for the Amelia Concourse MSBU Landscape Maintenance Annual Contract dated July 27, 2009, the performance period is hereby extended for an additional one (1) year beginning August 1, 2012 and ending July 31, 2013.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.




