**AMENDMENT NUMBER 3/THIRD EXTENSION TO THE  
PREVENTATIVE HYDRAULIC ELEVATOR MAINTENANCE AGREEMENT FOR  
NASSAU COUNTY HISTORIC COURTHOUSE**

THIS ADDENDUM entered into this 6th day of June, 2012 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **COASTAL ELEVATOR SERVICE CORPORATION**, 11290 St. Johns Industrial Parkway, Suite 1, Jacksonville, Florida 32246, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated August 1, 2008; and

**WHEREAS**, the original agreement provided for an initial term beginning August 18, 2008 and ending August 17, 2010, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

**WHEREAS**, the parties mutually agreed to extend the agreement for the periods beginning August 18, 2010 and ending August 17, 2012; and

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with "Term" section of the Preventative Hydraulic Elevator Maintenance Agreement for Nassau County Historic Courthouse dated August 1, 2008, the performance period is hereby extended for an additional one (1) year beginning August 18, 2012 and ending August 17, 2013.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
