# Loop Road Phase 1 Summary of Understanding

Nassau County intends to make assignment for the CEI inspection of a new connecting road (Loop Road) between Christian Way and License Road and associated roadway improvements in Nassau County under the master contract CM1582 (RFQ/Bid No NC10-002). The scope will include performing site inspections and contract administration in accordance with the master contract and all construction project documents.

#### **Project Information**

The project consists of new construction of Loop Road as a connector between the existing roads, Christian Way and License Road, and which will include roadway improvements along those existing roads. Plans and specifications are now available. Project discussions have indicated that the project's construction cost is approximately \$400,000 and the duration will be approximately 120 days until substantial completion, with another 30-45 days to reach final completion.

#### Scope of Services

CDM Smith proposes to provide CEI services within the context of this assignment and the scope of services associated with contract CM1582.

These services will be performed on a time and material basis during the course of this assignment with a limiting amount of \$87,086.82 using the following personnel/positions in either a periodic or continuous role as needed:

- Senior Project Engineer Part time as needed
- Project Administrator Part time as needed
- Administrative Assistant Part time as needed
- Senior Inspector Part time as needed
- Inspector Full time
- Asphalt Plant Inspector Part time as needed

The fee proposal (attached) utilizes the rates established in the contract. The fee is based on preliminary assignments as follows: Part-time for the administrative positions of Project Administrator and Administrative Assistant, full-time for the Inspector position for the project duration (including 10% for overtime), full-time for a Senior Inspector for 2 months (including 10% for overtime), part-time Inspector and Senior Inspector for the interim period between substantial completion and final completion, and part-time for a Plant Inspector as needed. The Senior Inspector is added to provide backup and additional services only if needed.
