AMENDMENT NUMBER 1/FIRST EXTENSION TO THE
AGREEMENT FOR UNIFORM RENTALS

THIS ADDENDUM entered into this 20th day of September, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **UNIFIRST CORPORATION**, 3029 Mercury Road, Jacksonville, Florida 32207, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated November 30, 2009; and

WHEREAS, the original agreement provided for an initial term beginning November 30, 2009 and ending November 29, 2011, with an option to extend three (3) times upon mutual contract between the vendor and the County for increments of one (1) year; and;

WHEREAS, the parties desire to amend and extend said Agreement.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


