AMENDMENT NUMBER 1/FIRST EXTENSION TO THE
AGREEMENT FOR DISPOSAL OF COUNTY GENERATED YARD/LAND
CLEARING WASTE AND CONSTRUCTION DEBRIS

THIS ADDENDUM entered into this 27th day of December, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **SANDHILL RECYCLE CENTER, INC.**, 153326 County Road 108, Yulee, Florida 32097, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated March 11, 2009 for disposal of county generated yard/land clearing waste and construction debris; and

WHEREAS, the original agreement provided for an initial term beginning March 11, 2009 and ending March 10, 2012, and allowed for two renewals of one year periods; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended, at the same cost, for an additional one (1) year beginning March 11, 2012 and ending March 10, 2013.

- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
