



**AMENDMENT NUMBER 1/FIRST EXTENSION TO THE**  
**AGREEMENT FOR CONTINUING CONTRACT FOR GEOTECHNICAL**  
**SERVICES**

THIS ADDENDUM entered into this 27th day of December, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **NODARSE & ASSOCIATES, INC.**, 1675 Lee Road, Winter Park, FL 32257, (hereinafter referred to as "Consultant").

**WHEREAS**, the parties entered into an Agreement dated May 13, 2009; and

**WHEREAS**, the original agreement provided for an initial term of three (3) years beginning May 13, 2009 and ending May 12, 2012, with an option to extend upon mutual contract between the Consultant and the County; any extension of performance period under this provision shall be in one (1) year increments.

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Article 4 of the Agreement dated May 13, 2009, the performance period is hereby extended for an additional one (1) year beginning May 13, 2012 and ending May 12, 2013
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.


