

**NINTH AMENDMENT TO PURCHASE, INSTALLATION AND  
MAINTENANCE SERVICE CONTRACT**

**Training, Maintenance and Warranty Service for the  
Nassau County E911 System**

**THIS AMENDMENT** made and entered into by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Ninth Amendment for training, maintenance, warranty and support for the E911 System and associated programs and applications.

**WHEREAS**, the parties entered into the original contract on the 20<sup>th</sup> day of January, 2009; and

**WHEREAS**, the equipment installation has been installed and is operational, and the maintenance and warranty period has begun; and

**WHEREAS**, the contract allows for the Solacom and PlantCML Extended Warranty to be adjusted annually by the manufacturer and provided by AK Associates at cost with no additional markup; and

**WHEREAS**, the State of Florida E911 Board approved the Spring 2012 Rural County Grant Program Application

request, E911 Rural County Grant No. 12-04-12 in the amount of \$62,312.25 and E911 Rural County Grant No. 12-04-26 in the amount of \$1,961.00; total grant award \$64,273.25 for E911 Maintenance.

**NOW, THEREFORE,** for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. SECTION II, 2. Costs, A. AK Elite Premier Maintenance and PlantCML Extended Warranty Payment Schedule as follows:






