

**FIRST EXTENSION TO THE AGREEMENT FOR WASTEWATER  
TREATMENT OPERATIONS ENVIRONMENTAL TESTING SERVICES  
FOR NASSAU-AMELIA UTILITIES**

THIS AGREEMENT entered into this 16th day of May, 2012 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Advanced Environmental Laboratories, Inc.**, (hereinafter referred to as "Vendor"), located at 6601 Southpoint Parkway, Jacksonville, Florida 32216.

**WHEREAS**, the parties entered into an agreement on November 23, 2009, for laboratory services for mandated analytical analysis testing for Nassau-Amelia Utilities; and

**WHEREAS**, the original agreement provided for an initial term beginning October 1, 2009 and ending September 30, 2012, and allowed for two renewals of one (1) year each; and


**WHEREAS**, the parties desire to amend and extend the said Agreement

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. The performance period is hereby extended, at the same cost, for an additional one (1) year beginning October 1, 2012 and ending September 30, 2013.

3. Time is of the essence.


