AMENDMENT NUMBER 4/FOURTH EXTENSION TO THE ASSA GOLD MAINTENANCE AGREEMENT FOR SOLID WASTE DEPARTMENT AT THE WEST NASSAU LANDFILL LOCATION

- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
