**AMENDMENT NUMBER 1/FIRST EXTENSION TO THE AGREEMENT  
FOR BOTTLED WATER**

THIS AGREEMENT entered into this ~~xxx~~<sup>28th</sup> day of ~~xxxxx~~<sup>June</sup>, 2013 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **NESTLE WATERS NORTH AMERICA**, located at 6403 Harney Road, Tampa, Florida 33610; (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into a piggyback agreement on April 3, 2012, based on the District School Board of Pasco County Bid #12-039-DR, for the purchase of bottled water for various departments and offices county wide; and

**WHEREAS**, the original agreement provided for an initial term beginning March 29, 2012 and ending March 28, 2013 with an option to renew for two, one year terms;

**WHEREAS**, District School Board of Pasco County renewed their agreement and the County desires to sync their contract period to match District School Board of Pasco County; and

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended for an additional period beginning March 29, 2013 and ending September 16, 2013.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
