AMENDMENT NUMBER 1/FIRST EXTENSION TO THE CONTRACT FOR PHARMACEUTICAL SUPPLIES FOR FIRE RESCUE

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 20 of the Agreement dated November 8, 2010, the performance period is hereby extended for an additional one (1) year beginning October 1, 2012 and ending September 30, 2013.
- 2. In accordance with Section 23 of the Agreement dated November 8, 2010, the prices on the following items will be increased to the pricing listed herein:
