AMENDMENT NUMBER 3/THIRD EXTENSION TO THE
AGREEMENT FOR FIRE ALARM INSPECTION SERVICES AT
FERNANDINA BEACH PUBLIC LIBRARY

THIS ADDENDUM entered into this 24th day of May, 2012 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **B.J. BARR'S PERSONAL SAFETY DEVICES dba ISLAND SECURITY**, P.O. Box 16539, Jacksonville, Florida 32245, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated September 10, 2009 for fire alarm monitoring and annual fire alarm inspection services for Fernandina Beach Public Library; and

WHEREAS, the original agreement provided for an initial term beginning October 1, 2009 and ending September 30, 2010, and allowed for renewals of one year periods; and


WHEREAS, the parties agreed to extend the agreement for subsequent periods beginning October 1, 2010 and ending September 30, 2012; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended, at the same cost, for an additional one (1) year beginning October 1, 2012 and ending September 30, 2013.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
