AMENDMENT NUMBER 2/SECOND EXTENSION TO THE
AGREEMENT FOR UNIFORM RENTALS

THIS ADDENDUM entered into this 25th day of September, 2012 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **UNIFIRST CORPORATION**, 1446 Haines Street, Jacksonville, Florida 32206, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated November 30, 2009; and

WHEREAS, the original agreement provided for an initial term beginning November 30, 2009 and ending November 29, 2011, with an option to extend three (3) times upon mutual contract between the vendor and the County for increments of one (1) year; and;

WHEREAS, the parties agreed to extend the agreement for the period beginning November 30, 2011 and ending November 20, 2012; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 5 of the Agreement for Uniform Rentals dated November 30, 2009, the performance period is hereby extended for an additional one (1) year beginning November 30, 2012 and ending November 29, 2013.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.


