**AMENDMENT NUMBER 5/FIFTH EXTENSION TO THE  
ASSA GOLD MAINTENANCE AGREEMENT FOR SOLID WASTE  
DEPARTMENT AT THE WEST NASSAU LANDFILL LOCATION**

THIS ADDENDUM entered into this 19th day of July, 2013 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **ATLANTIC SECURITY CONSULTANTS, INC.**, 1714 Cesery Boulevard, Jacksonville, Florida 32211, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated October 13, 2008; and

**WHEREAS**, the original agreement provided for an initial term beginning October 13, 2008 and ending October 12, 2009, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and


**WHEREAS**, the parties agreed to extend the agreement for the subsequent periods beginning October 13, 2009 and ending October 12, 2013; and

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 6 of the Agreement dated October 13, 2008, the performance period is hereby extended, at the same cost, for an additional one (1) year beginning October 13, 2013 and ending October 12, 2014.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
