

**AMENDMENT NUMBER 2/SECOND EXTENSION TO THE CONTRACT FOR SAISS PROJECT ESCARPMENT REMOVAL AND TILLING**

THIS AMENDMENT entered into this 24th day of February, 2014 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **EASTMAN AGGREGATE ENTERPRISES, LLC**, 3705 Bellevue Avenue, Lake Worth, Florida 33461, (hereinafter referred to as "Contractor").

**WHEREAS**, the parties entered into an Agreement dated March 22, 2012; and

**WHEREAS**, the original agreement provided for an initial term beginning March 22, 2012 and ending March 21, 2013, with an option to extend for four (4) additional one (1) year periods upon written agreement of both parties; and

**WHEREAS**, the parties agreed to extend the agreement for the period beginning March 22, 2013 and ending March 21, 2014; and

**WHEREAS**, the parties desire to amend and extend said Agreement; and

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 2 of the Contract for SAISS Project Escarpment Removal and Tilling dated March 22, 2012, the performance period is hereby extended for an additional one (1) year beginning March 22, 2014 and ending March 21, 2015.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
