**AMENDMENT NUMBER 2/SECOND EXTENSION TO THE
CONTRACT FOR SAISS PROJECT SHOREBIRD MONITORING SURVEYS**

THIS AMENDMENT entered into this 27th day of February, 2014 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **SCHEDA ECOLGICAL ASSOCIATES, INC.**, 5892 East Fowler Avenue, Tampa, Florida 33617, (hereinafter referred to as "Contractor").

WHEREAS, the parties entered into an Agreement dated April 4, 2012; and

1. In accordance with Section 2 of the Contract for SAISS Project Shorebird Monitoring Surveys dated April 1, 2012, the performance period is hereby extended for an additional one (1) year beginning April 1, 2014 and ending March 31, 2015.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.

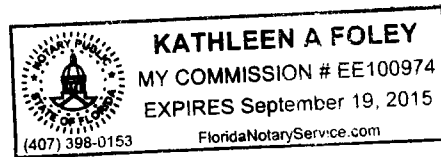
