

**AMENDMENT NUMBER 2/SECOND EXTENSION TO THE AGREEMENT FOR  
RISK MANAGEMENT SERVICES**

THIS ADDENDUM entered into this 18th day of September 2013, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a **political subdivision of the State of Florida**, hereinafter referred to as "County", and **John T. Ferreira Insurance**, located at 463820 State Road 200, Suite 101, Yulee, Florida 320397 hereinafter referred to as "JTF".

**WHEREAS**, the parties entered into an agreement dated June 27, 2011; and

**WHEREAS**, the original agreement provided for an initial term beginning July 1, 2011 and ending September 30, 2012, with an option to extend "as needed" for a period of twelve (12) months, not to exceed a total period of three (3) years; and

**WHEREAS**, the parties agreed to extend the agreement for the period beginning October 1, 2012 and ending September 30, 2013; and


**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements hereinafter contained, the parties hereto agree as follows:



1. In accordance with Section 4.1 of the Risk Management Services Agreement dated June 27, 2011, the performance period is hereby extended for an additional period beginning October 1, 2013 and ending June 30, 2014.
2. In accordance with Section 2.1 of the Risk Management Services Agreement dated June 27, 2011, quarterly payments of Six Thousand, Two Hundred and Fifty Dollars (\$6,250.00) shall be made for the performance period of this extension. Total payments for this performance period shall total Eighteen Thousand Seven Hundred and Fifty Dollars (\$18,750.00)

3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
4. Time is of the essence.


