

**FUNDING AGREEMENT FOR FISCAL YEAR 2013-2014 FOR BARNABAS CENTER**

This agreement entered into this 9th day of December, 2013, by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as COUNTY, and **BARNABAS CENTER**, 11 South 11<sup>th</sup> Street, Fernandina Beach, Florida, 32034, hereinafter referred to as CENTER.

**WHEREAS**, it is in the best interest of the citizens of Nassau County that the CENTER continue, and work with the economically deprived citizens of Nassau County, and

**WHEREAS**, the CENTER now maintains services for the economically deprived residents of Nassau County;

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. For the sum of \$1,620.00, which shall be paid in quarterly installments, during the months of December, February, May and August of the fiscal year, the CENTER does hereby agree to perform services that will benefit the residents of Nassau County. Appropriations necessary for the funding of this Agreement beyond 2014 shall be subject to the budget and appropriation by the Board of County Commissioners during the regular budget process. Said services to include but not be limited to the

following:

- a. Continuing the present level of services provided for the citizens of Nassau County.
2. Barnabas Center shall submit simultaneously to the County Manager and the Clerk an annual accounting acceptable to the Clerk on or before May 1<sup>st</sup> of each fiscal year in which Barnabas Center received funding from the County. Additionally, Barnabas Center shall make its books available for inspection by a designee of the County upon reasonable notice. Failure of Barnabas Center to provide the annual accounting record by the time specified shall result in the revocation of granting of further funds and reimbursement of funds distributed during the year for which no report was submitted.
3. All facilities, programs and services shall be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, and services that are compliant with both the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA) shall be considered a breach of the contract.
4. The term of this agreement shall commence on October 1, 2013 and terminate on September 30, 2014.
5. This Agreement shall be amended in writing from time to time by mutual consent of parties.

IN WITNESS WHEREOF, the effective date of this Agreement shall be the date of its being signed by the Designee of the Board of County Commissioners of Nassau County, Florida, this 9th day of December, 2013.
